【解读】三定方案：海关总署职能配置、内设机构和人员编制规定

近日，海关总署三定方案确定。方案明确将成立自贸区和特殊区域发展司，牵头拟订自由贸易区等海关特殊监管区域发展规划、监管制度，承担自由贸易区等海关特殊监管区域的设立和事中事后监督工作。中食安信认为，此举将从两个方面对跨境、自贸区等造成影响。

1. 跨境、自贸区等进口渠道将纳入监管，准入产品清单将会得到进一步完善。
2. 跨境电商商品将不能置身于法外之地，其产品质量、食品安全问题等会被相关法规予以规范。

此外，进出口食品安全局明确归属于海关，将负责进口食品企业的备案注册事宜。由此看来，水产、乳品（包括婴幼儿配方奶粉）、肉类、燕窝等进口食品企业注册职能将由认监委（CNCA）转到海关总署。

GACC MOA Order 99 of 2018 (Announcement on Preventing the Introduction of the Small Ruminant Animal Epidemic to China)

The announcement includes prohibiting the direct or indirect importation of cattle, sheep and related products from Bulgaria, the suspension of the issuance of the relevant *Quarantine of Entry Animals and Plants*, the revocation of *Quarantine of Entry Animals and Plants* already issued, etc. The announcement shall be executed as of the date of promulgation. Regulations of GACC

Recently, the internal structure and functions of the General Administration of Customs, P. R. China (GACC) was determined. According to the internal documents, there will be a new division, the Division for Development of Free Trade Zone and Special Area, in the GACC. The division shall lead to establish the development plan, supervision rules, and be in charge of operational and post-operational oversight for special customs supervisory areas.

Antion believe the establishment of the new division will result two things.

First, the import channels, through cross-border e-commerce and free trade zones, will be taken into oversight. The List for Access-permitted Products will be extended and clarified.

Second, there will be regulations and standards to regulate the quality and safety of foods imported through cross-border e-commerce.

In addition, Food Safety Bureau for Import and Export is clearly attributable to the GACC, and it is in charge of the recordation and registration of the import food enterprises. It means the responsibilities of CNCA is largely transferred to GAC. The registration for foreign manufacturers of aquatic products, dairy products (include milk-based infant formula), meat and cubilose will be taken by the GACC.
