### **SAMR Notification on Issuing Supervision and Inspection Plan on Food Safety of 2019**

There are 31 categories of sampling objects, including meat products, beverages, alcohol, edible agricultural products (including beef and sheep meat, etc.), etc., and the sampling items on beef and sheep meat include total volatile base nitrogen, clenbuterol and salbutamol, etc. (SAMR 2019-02-01)

### **The Announcement of the GACC on Matters Related of the Food Inspection and Release that Enter into the Comprehensive Bonded Zone**

Any laboratory test that needs to be carried out may be released after sampling on the basis of the following conditions: (1) The importer promises that the imported food conform to the national food safety standards and relevant inspection requirements (including packaging requirements and requirements of storage and transportation temperature, etc.). (2) The importer has established a sound food import record and sales record system and strictly implemented it. (GACC 2019-02-02)

### **List of Meat Products from Countries or Regions that Meet the Requirement of Assessment and Review (Update on February 26 of 2019)**

Two new Uruguayan enterprises (Register No. 20 and 74) exporting frozen beef and sheep meat to China were added. From February 1<sup>st</sup> of 2019, the beef and sheep meat produced on or after February 1<sup>st</sup> of 2019 that meet the Chinese requirements could be imported to China; Due to foot-and-mouth disease occurred in South Africa, GACC and MARA issued the announcement on prevention of food-and-mouth disease in South Africa into China (No. 34 of 2019) and suspended the import of beef products from South Africa to China starting from February 26 of 2019. The Ministry of Agriculture, Forestry and Fisheries of Japan said that a hog farm in Toyota city, Aichi-ken confirmed that hogs were infected with swine fever (Non-African swine fever). Five prefectures including Aichi-ken, Osaka prefecture, Nagano-ken, Gifu-ken and Shiga-ken, where piglets were purchased from the above farm, were also confirmed to be infected with swine fever.
