On March 8 of 2019, GACC updated the restoration of beef products from Uruguay Marfrig's Frigorifico La Caballada (Cledinor S.A.) (394) and Brazil's Bon-Mart Frigorifico Ltda (SIF2121) produced that meet the Chinese requirements could be imported to China on or after March 7 of 2019; on March 22 of 2019, GACC updated that frozen and ice fresh beef products from four new French enterprises produced that meet the Chinese requirements could be imported to China on or after March 8 of 2019.
